Reimbursements: It was moved, seconded and voted to reimburse Bob and Sue Chapin and Jack Quirk for their expenditures on behalf of Thomas Pond Improvement Association.

The water level was drawn down to 28" this past winter. It was noted that there were no adverse effects. Alan Aaskov noted that he appreciated the 28" drawdown. There was discussion on the water levels and the impact of higher and/or lower water levels.

There was discussion regarding dam insurance and the cost for that insurance if it could be obtained. There is no insurance for the dam at this time. TPIA will continue to look for insurance for the dam.

There was discussion regarding the election of the Officers and Board of Directors for TPIA and representation for each area of Thomas Pond.

Following the discussion, it was moved, seconded and voted to elect Brook Hidell as the representative for the Quaker Ridge Road section of Thomas Pond.

It was moved, seconded and voted to elect Frank Jaffe as the representative for the Pulpit Rock Shores section of Thomas Pond.

There was then discussion on marking of the submerged rocks in Thomas Pond. It was noted that there was no protocol for how that is done.

Election of Officers:

It was moved, seconded and voted to elect the current slate of officers for TPIA to serve for another year.

The Officers and Board members recognized Dick Horr, VLMP Water Quality Monitor; and Nicholas Cody, who monitors Thomas Pond for invasive plant species, for their time and dedication to help maintain a healthy Thomas Pond.

It was moved, seconded and voted to increase the amount for the Courtesy Boat Inspectors to \$817.50.

It was moved, seconded and voted to adjourn the meeting at 9:55 a.m.
