Guest Speaker:

Raymond Fire Chief Bruce Tupper gave a presentation to the group regarding a recent structure fire on Thomas Pond Terrace. Chief Tupper spoke on how to help protect your property from fires by keeping leaves, brush, flammable materials, etc. cleared away from your house/cottage and outbuildings. Chief Tupper emphasized that it is important to have your house numbers clearly visible from the road so that fire and rescue personnel will be able to locate your house quickly in case of an emergency.

Bob Chapin spoke on the state of Thomas Pond. He said that everything is about the same as last year (Secchi disk and oxygen readings). The logs that were on the dam have been removed. Bob said the loon count is down this year and David Morton noted he saw three loons today. Bob said that the other birds observed were about as normal. He also noted the fishing is good.

Bob thanked Gil and Mark Richards for removing the logs that were on the dam and thanked Nicholas Cody for patrolling for invasive plants. It was noted that there is some Purple Loosestrife in Thomas Pond.

Dick Horr spoke on the water quality of Thomas Pond and noted that the dissolved oxygen readings and the Secchi Disk (5 Meters) readings were about the same as last year.
