Dear Attorney Coffin,

Thank you for your letter of October 21, 2023, containing the Thomas Pond Improvement Association ("TPIA" or "Association") Board of Directors' ("Board") response to Attorney Brady's correspondence of August 8, 2023 (the "Brady Letter"). I write in reply to the Board's request for confirmation that my clients, Steven Kelsey Hazen, Robert Long Murch, and C. Dana Watkins (collectively, my "Clients"), are members of, or otherwise exercise membership rights in, the TPIA. This reply is limited to that issue and is delivered for the purpose of satisfying the Board that my Clients' possess membership rights in the Association.

The basis for each of my Clients' membership in (or the right to act on behalf of members of) the TPIA is set forth below.

Steven Kelsey Hazen

As the Board recognized, Mr. Hazen represented the interests of Loyd C. Locklear and Robert E. MacDonald, both members of the Association, at the 2022 Annual Meeting as their agent under Power of Attorney. The form of Power of Attorney used for that purpose was replaced with one that extended more broadly than an Annual Meeting and indefinitely. It also included a power of appointment and substitutions (the "Power of *Celebrating over 50 years and thousands of valued relationships*

Appointment"). Mr. Hazen was not able to attend the 2023 Annual meeting and thus executed a Power of Appointment in favor of Attorney Colby Wallace (the "Wallace Appointment"). Mr. Hazen understands that Attorney Wallace provided executed copies of the updated Power of Appointment and the Wallace Appointment to the person identified to him at the 2023 Annual Meeting as being the Secretary of the Association, Ms. Sue Chapin.

Mr. Hazen is the agent under a Maine Durable Limited Power of Attorney from Robert E. MacDonald dated June 9, 2023 (copy enclosed) (the "MacDonald POA"). The MacDonald POA authorizes Mr. Hazen to act on Mr. MacDonald's behalf with respect to exercising Mr. MacDonald's membership rights in the Association. Mr. MacDonald is a member of the Association by virtue of his ownership of property with a deeded right of access to the shore of Thomas Pond at 20 Valley Road, Casco, Maine, which property is shown on the Town of Casco Tax Map 3A, Lot 5, and was deeded to Mr. MacDonald by the Estate of Natalie Pushard by Corrective Deed of Sale by Personal Representative (Testate) dated June 21, 2006, and recorded at the Cumberland County Registry of Deeds Book 24124, Page 134 (copy enclosed).

Robert Long Murch

Mr. Murch exercises membership rights in the Association by virtue of being the Manager of the Annie Susan Murch Kelsey Family Camp Thomas, LLC (the "LLC") and as personal representative of the estate of his mother, Lela B. Murch (the "Estate"), which owns property at Murch Point on Thomas Pond.

As the Board acknowledged, the LLC is a member in the Association by virtue of its ownership of a lot on the shore of Thomas Pond at 70 Murch Point Road, Casco, Maine, which property is shown on the Town of Casco Tax Map 14, Lot 3, and was deeded to the LLC from the Prudence Eleanor Hazen (née Kelsey) Revocable Trust Agreement, dated 04/17/2009, by Warranty Deed dated September 30, 2019, and recorded at the Cumberland County Registry of Deeds in Book 36027, Page 134 (copy enclosed). I have reviewed the LLC's Limited Liability Company Agreement with an effective date of August 8, 2019, as amended and restated, and can represent to you and confirm that:

- 1. Mr. Murch holds a controlling membership interest in the LLC;
- 2. The LLC is a manager-managed LLC;
- 3. Mr. Murch is the Manager of the LLC; and
- 4. Mr. Murch, as Manager of the LLC, has the authority to act on behalf of the LLC in matters related to the TPIA.

In addition to the above, Mr. Murch's mother, Lela B. Murch, was a member of the Association by virtue of her joint ownership with her husband, Albert K. Murch, of a

one-third interest in a lot situated on the shore of Thomas Pond. Mrs. Murch and her husband acquired their one-third interest in the property as joint tenants from Beverly M. Hall, Albert K. Murch, and Mary I. Sawyer by Warranty Deed dated February 17, 1992, and recorded at the Cumberland County Registry of Deeds in Book 9917, Page 194 (copy enclosed). Her husband having predeceased her, Mrs. Murch passed away in 2019. The Estate is being probated at the Androscoggin County Probate Court under docket number 2019-373. Mr. Murch was appointed personal representative of the Estate by the Probate Court on August 19, 2019. A Certificate and Abstract for the Estate, dated August 19, 2019, was recorded at the Cumberland County Registry of Deeds in Book 35910, Page 47 (copy enclosed).

C. Dana Watkins

Mr. Watkins is a member of the Association by virtue of his ownership of a lot on the shore of Thomas Pond. Mr. Watkins' lot is shown on the Town of Casco Tax Map 2, Lot 36B, which property was deeded to Mr. Watkins in common with others from the Estate of Dorothy L. Corson by Deed of Distribution by Personal Representative (Testate) dated December 15, 2000, and recorded at the Cumberland County Registry of Deeds in Book 15924, Page 85 (copy enclosed).

Further reference is made to a document provided by the TPIA purporting to be a list of TPIA members entitled "2023 TPIA Eligible Property Members", as of 5/26/23 8:24 AM (copy enclosed), which reveals records on page 8 of 9 of Mr. Watkins' membership in the Association.

MAINE DURABLE LIMITED POWER OF ATTORNEY

- I, ROBERT E. MACDONALD, owner of real property located at 20 Valley Road, Casco, Maine and by virtue thereof having deeded real property rights of access to Thomas Pond, located in the Towns of Casco and Raymond, Cumberland County, Maine, do hereby make, constitute and appoint STEVEN KELSEY HAZEN as my agent (being hereinafter referred to as my "Agent") and having full authority to act for me and in my name, place and stead, in any and all of the following matters and purposes specified herein:
- 1. Voting rights related to Thomas Pond Improvement Association, Inc., a Maine non-profit corporation ("TPIA"), including, but not limited to, the power and authority to exercise any voting rights with respect to TPIA, or any successor thereto, in person or by written proxy.
- 2. Voting rights related to operation of the so-called Thomas Pond Dam (aka the "Dingley Brook Dam"; herein the "Dam"), as described below, including, but not limited to, the power and authority to exercise any voting rights with respect to the Dam, in person or by written proxy.
- 3. The right to attend any meetings or discussions of TPIA, or any successor thereto, and to speak, or refrain from speaking, on my behalf.
- 4. The right to attend any meetings or discussions related in manner to the Dam, as described below, and to speak, or refrain from speaking, on my behalf.
- 5. Without in any way limiting the aforesaid powers or any of them by implication or otherwise, I give to my agent the power and authority to do and perform all other acts, matters or things whatsoever not specifically mentioned herein but arising out of or connected in any manner with TPIA and/or my rights and interests, riparian or otherwise, in the operation, maintenance, and/or control of the Dam as described in a Quitclaim Deed dated July 2, 1990 (recorded in the Cumberland County Registry of Deeds in Book 9240, Page 21), from the State of Maine to TPIA, which deed awarded ownership of the Dam and authority for operation of it to TPIA while also imposing requirements upon TPIA.

General and Miscellaneous Provisions: This power of attorney shall be effective immediately and shall not be affected by my disability or any lack of competence suffered by me and arising after the date hereof. Lapse of time shall not affect the validity of this power of attorney, except as specified herein. To specifically limit the scope of Section 5-914(8) of MUPAA, I hereby state that my Agent is not required to disclose receipts, disbursements or transactions to any person except me, to any co-agent, to my conservator and, following my death, to the personal representative

of my estate. I hereby exonerate my Agent from liability for a breach of any duty except for any breach committed dishonestly, with improper motive, or with reckless indifference to the purposes of this power of attorney. The provisions of this instrument shall be severable and, in the event any of them is deemed void or ineffective by a court of law, or any other authority, the others shall continue in full force and effect as and to the extent specified herein. A photocopy or electronically transmitted copy of this power of attorney has the same effect as the original. The validity and effect of this instrument shall be governed by, and the terms of this instrument shall be construed in accordance with, the law of the State of Maine.

Revocation/Cancellation/Termination: Principal puts Agent on notice herewith, and Agent acknowledges, that the authority of Agent specified herein may be revoked, cancelled, and/or terminated by Principal at any time by written notice thereof to Agent and to the Board of Directors of the TPIA. Principal acknowledges that the duties and authority of Agent specified herein may be terminated by Agent at any time by written notice to Principal and that Principal and Agent may terminate their relationship hereunder by mutual agreement, including any procedures covering notice to others of such termination.

Power of Delegation/Substitution: Principal grants to Agent the authority to delegate another person to act on behalf of the Agent at any meeting of the TPIA members, Board of Directors, and/or officers of the TPIA which Agent is unable to attend and which might cover matters relating to the Dam. Agent shall exercise care, competence and diligence in selecting and monitoring the person to whom any authority has been so delegated. Agent or the person delegated shall inform any third party about the delegation as the Agent deems reasonably necessary to achieve the Principal's purposes.

Notice to the Principal (required by Maine law): As the "Principal" you are using this power of attorney to grant power to another person (called the Agent) to make decisions about your property and to use your property on your behalf. Under this power of attorney you give your Agent broad and sweeping powers to sell or otherwise dispose of your property without notice to you. Under this document your Agent will continue to have these powers after you become incapacitated. The powers that you give your Agent are explained more fully in the Maine Uniform Power of Attorney Act, Maine Revised Statutes, Title 18-A, Article 5, Part 9. You have the right to revoke this power of attorney at any time as long as you are not incapacitated. If there is anything about this power of attorney that you do not understand, you should ask an attorney to explain it to you.

Notice to the Agent (required by Maine law): As the "Agent" you are given power under this power of attorney to make decisions about the property belonging to the Principal and to dispose of the Principal's property on the Principal's behalf in

accordance with the terms of this power of attorney. This power of attorney is valid only if the Principal is of sound mind when the Principal signs it. When you accept the authority granted under this power of attorney a special legal relationship is created between you and the Principal. This relationship imposes upon you legal duties that continue until you resign or the power of attorney is terminated or revoked. The duties are more fully explained in the Maine Uniform Power of Attorney Act, Maine Revised Statutes, Title 18-A, Article 5, Part 9 and Title 18-B, sections 802 to 807 and Title 18-B, chapter 9. As the Agent, you are generally not entitled to use the Principal's property for your own benefit or to make gifts to yourself or others unless the power of attorney gives you such authority. If you violate your duty under this power of attorney you may be liable for damages and may be subject to criminal prosecution. You must stop acting on behalf of the Principal if you learn of any event that terminates this power of attorney or your authority under this power of attorney. Events of termination are more fully explained in the Maine Uniform Power of Attorney Act and include, but are not limited to, revocation of your authority or of the power of attorney by the Principal, the death of the Principal, or the commencement of divorce proceedings between you and the Principal. If there is anything about this power of attorney or your duties under it that you do not understand you should ask an attorney to explain it to you.

Ratification of Prior Acts: Principal hereby ratifies the acts of the Agent performed under any other limited power of attorney granted by Principal to Agent at any time prior to the date hereof, including, but not limited to, any acts the Agent performed prior to or after the purported expiration date of any such limited power of attorney.


